Investment Policy

In order to achieve its investment objective, the Company invests in a diversified portfolio of shares and related securities in biotechnology companies on a worldwide basis. The Company will not invest more than 15% of the value of its gross assets in any one individual stock at the time of acquisition. No more than 10% of gross assets will be invested in unquoted investments at the time of acquisition. This investment or limit includes any commitment to invest in private equity funds managed by OrbiMed or an affiliate thereof. Investments or commitments to invest in such private equity funds will be limited to US15m, after the deduction of proceeds of disposal and other returns of capital. The Company's borrowing policy is that borrowings will not exceed 20% of value of the Company's net assets. The Company may be unable to invest directly or efficiently in certain countries or share classes. In these circumstances, the Company may gain exposure by investing indirectly through swaps or other derivative instruments. Exposure to these financial instruments will count towards and be subject to the following limits: Derivative transactions (excluding equity swaps) can be used to mitigate risk and/or enhance return and will be restricted to an aggregate net exposure of 5% of the value of the gross assets measured at the time of the relevant transaction; Equity swaps may be used for efficient portfolio management purposes and aggregate net counterparty exposure through a combination of derivatives and equity swap transactions is restricted to 12% of the value of the gross assets of the Company at the time of the transaction.

Commentary

In August, the NAV per share was down 0.5%, the share price was down 1.6% and the benchmark NASDAQ Biotechnology Index (sterling adjusted) was down 1.4%.

Biotech was generally weak in August, trading roughly in-line with the NASDAQ Composite Index. Markets dropped at the beginning of the month due to a weaker-thanexpected U.S. jobs report that raised investors' expectations of a possible recession. Stocks were also weak due to a surprise hike in interest rates by the Bank of Japan, which forced the partial unwind of a "carry" trade which seeks to monetize the difference between U.S. and Japanese interest rates. A Federal Reserve interest rate cut in September is now a near certainty, with the primary investor debate about whether it will be a 0.25% or 0.50% cut. We are hopeful the start of interest rate cuts in September will lead to a sustained recovery in biotech.

On the political front, Kamala Harris officially became the presidential nominee for the Democratic party, which has led to a tightening of the presidential race. While many sectors of the economy may trade on election year dynamics heading into November, we don't think major healthcare reform will be a core topic of either political party in 2024. As such, we think the risk to biotech heading into the election is minimal, with the only potentially adverse scenario one in which the Democrats take control of the presidency and both chambers of Congress. We think this is unlikely and continue to believe that a split government, with no single party controlling both Congress and the presidency, will be the most likely outcome. Under those circumstances, we do not believe major legislation would be passed that would adversely affect the biotech sector.

QuantumPharm, Phathom Pharmaceuticals, and Compass Therapeutics were the largest positive contributors to performance during the month. QuantumPharm's stock price appreciated after it entered into a strategic R&D collaboration agreement with GCL Group in August, under which GCL is expected to pay R&D service fees of over \$135 million. Phathom's stock rallied in August as prescriptions for its gastroesophageal reflux drug, Voquezna, continued to grow following the U.S. Food and Drug Administration ("FDA")'s approval of a label expansion for the drug and improved payer coverage. Compass outperformed in August as investors increasingly focused on upcoming pivotal biliary tract cancer data expected in early 2025.

Acadia Pharmaceuticals, Lexicon Pharmaceuticals, and Vir Biotechnology were the largest negative contributors to performance during the month. Acadia underperformed in August after reporting Rett syndrome drug sales that underperformed market expectations. Lexicon's share price declined in August due to general market weakness and the announcement that an FDA Advisory Committee meeting would be held to discuss potential approval of Zynquista in Type 1 diabetes, raising the risk to approval. The share price of Vir fell upon announcement of the in-licensing of a T-cell engager program from Sanofi, which investors did not perceive favorably.

The Directors have adopted an active discount management policy to establish and support an improved rating in the Company's shares through the use of share buybacks, with a view to limiting the discount to NAV per share at which the shares trade to no more than 6%. Shares bought back will be cancelled.
